## AHP Online System Now Open for 2020 Application Input

The 2020 funding round for the Affordable Housing Program (AHP) is now open **with approximately \$28.6 million** in available funding. All 2020 forms, guides and application attachments are currently available on [FHLBank's website](#). Forms may be downloaded, completed and then uploaded to the AHP Online system. Application assistance for 2020 AHP projects is available through June 30.*

2020 AHP applications are due **by 5 p.m. Eastern time on Tuesday, Aug. 11**. The awarded projects will be announced on Friday, Dec. 18.
